

2010 Annual Scholarship

Two Awarded - 1-Year \$3,000.00 Scholarships

QUALIFICATIONS

1. Any employee or immediate family member of an employee of a PBX member firm is eligible to apply.
2. Applicants must have completed 30 credit hours and be a full-time student matriculating in their sophomore to senior year in an accredited College or University in the US.
3. Applicants must have a minimum of a B grade average and submit official transcripts of grades to date.
4. Scholarship awards are competitive and will be based on:
 - a. Current grade point average.
 - b. Academic standing in high school.
 - c. Career choice as it relates to the construction industry.
 - d. Extracurricular activities.
 - e. SAT Scores or ACT Scores.
 - f. Demonstration of Leadership qualities and work ethic.
 - g. Your personal letter stating qualifications for the scholarship.



SELECTIONS

1. Applicants must submit a complete application, including criteria listed above within the specified deadlines for consideration.
2. Applicants are required to submit a personalized letter stating qualifications along with educational and career goals.
3. Finalists may be interviewed by the scholarship committee and a neutral professional before final selections are made.

RETENTION

1. The award will not be forfeited if the applicant's parents or guardian become inactive in the PBX after the award is granted.
2. If the recipient is drafted into military service, the recipient is eligible to receive the full amount of the award once a full-time student.
3. Any change in the educational status of the scholarship recipient must be reported to the scholarship committee.

PAYMENTS

The awards will be made payable to the recipient and the university or college, which they are attending after any other financial aid has been awarded. All awards will be on a one-time basis.

TERMINATION

The PBX Board of Directors will have the right to revise, change or cancel the scholarship awards program as it deems necessary.

DEADLINES

Submission of complete applications and supporting documents must be made by July 9, 2010. Awards will be announced by July 31st.
